Terms and Conditions

- 1) Rates are not commissionable. Rates include fuel and security surcharges, however screening fee or any other surcharges and taxes will apply.
- 2) Rates apply to Foodstuff only:
 - Includes: Vegetables, Fruits, Dairy, Meat and all Foodstuffs
 - Excludes Seafood, Articles of Extraordinary Value, Human Remains, Live Animals, Tropical Fish or Dangerous Goods.
- 3) Rates are applicable to Standard service only.
- 4) Charges will be based on the applicable rate multiplied by the chargeable weight of the shipment and subject to minimum requirements.
- 5) Tariff rules apply to all shipments; domestic or international.
- 6) The air waybill must always be used and completed in its entirety.
- 7) Shipper is responsible for ensuring:
 - a) The Shippers Delta account number is entered in the "Shipper Account Number" block of the air waybill.
 - b) A product has been selected in the "Service Description" block (DASH, Standard, DASH Heavy, PetFirst, Other). Only one product can be selected per air waybill.
 - c) The SCR Commodity Code 2000 is placed in the "Commodity Item Number" section of the air waybill when applicable.
- 8) Routes are subject to change without prior notice; discontinuance of service to any point shall nullify rates to or from that point.
- 9) Shipments of articles subject to IATA Dangerous Goods Regulations and/or Dry Ice will be assessed additional surcharges.
